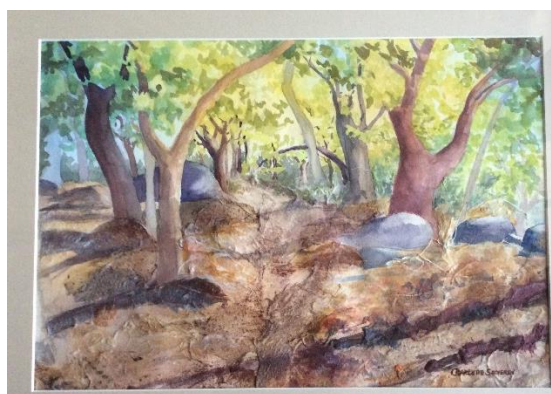

## ARTIST'S CONTRACT FOR 'KEEP HOPE ALIVE' EXHIBIT

1. This is a public space. *No nudes, religious, or political statements* in the content of the artwork.
2. All 2D artwork must be *wired for hanging*. 3D works will be exhibited under clear plastic cubes.
3. *On the back of each work*, a label should clearly state:
  - Artist's Name
  - Title
  - Medium
  - Price or NFS
4. Artist's *contact information* can be on the bio sheet in the exhibit book.
5. ***Sales are handled between the Artist and the Buyer.*** Castro Valley School Unified District charges a ***sales commission of 20%***. Artist agrees to send a commission check to CVUSD offices on 4400 Alma Avenue, Castro Valley, 94546.
6. All art work on exhibit stays on the walls until the exhibit closes, including purchased art.
7. Neither A.R.T., Inc. nor the Castro Valley Unified School District assume any responsibility for loss or damage to artwork.
